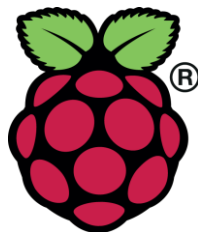
## LETTER OF AUTHORISATION


